Dear Prospective Basketball Captain:

Thank you for your interest in the Vernon Hills Park District's Adult Basketball Leagues. We strive to offer quality recreational opportunities for the residents and business community. The Vernon Hills Park District offers a variety of leagues to suit everyone's need.

The winter 2012 session of basketball will start in early January and end with a post-season tournament in late March. This league is divided into three divisions based on level of play. Teams may play cross divisional games depending on total league registration. Please indicate your preference of division with registration.

- Men's Gold League – competitive league comprised of players with average to above average basketball abilities
- Men's Silver League – recreational league comprised of players with average basketball abilities
- Men's Bronze League – recreational league comprised of players with little or no organized basketball experience

Each team is guaranteed 10 games in the regular season with the top four teams competing in a single elimination tournament. There will be a cash award to the top finisher in the regular season and t-shirts will be awarded to the tournament champions.

Games will be played at either the Sullivan Community Center or local schools. Games will be held on Tuesday and/or Thursday evenings. Start time for games will be 6:30, 7:30 and 8:30 PM.

# Vernon Hills Park District Winter Basketball League FAQ

## How much does it cost to play?

- The fee for resident teams is \$650
- The fee for non-resident teams is \$700

## What is a “resident team”?

- A resident team has a minimum of 60% of their roster filled with residents of the Vernon Hills Park District.
- A team comprised of players from a Vernon Hills business will also be considered a resident team. Corporate teams must provide verification, on company letterhead, from the human resources department that players are currently employed by the organization

## What is due at the time of registration?

- A \$200 non-refundable deposit
- Copy of the roster with names, and addresses of all players (signatures are required by the first game).

## When is the balance of the league fee due?

- At the mandatory captain’s meeting.

## When is registration?

November 1-6	Teams with 60% residents
November 7-13	Returning non-resident teams
November 14	Open Registration
December 16	Registration Deadline

## I want to play, but I don’t have a team, what should I do?

- We only take registration by team. Individuals may contact Joe Bruntmyer to be placed on a list of individuals looking for a team. If a team is in need of additional players, this list will be made available.

**VERNON HILLS PARK DISTRICT PROGRAM  
WAIVER, RELEASE, AND CONSENT TO BE PHOTOGRAPHED**

Please read this form carefully and be aware that, by registering for, and for participating in, Vernon Hills Park District ("District") programs, you are releasing all claims for injuries arising out of these programs that you or your minor child or ward who is a named participant might sustain. In registering for these programs, you are agreeing as follows:

As a participant (or the parent or guardian of a minor participant) in these programs, I recognize and acknowledge that there are certain risks of physical injury, and I agree to assume the full risk of any damages or loss which I (or my minor child or ward) may sustain as a result of participating, in any manner, in any and all activities connected with or associated with such programs. I further recognize and acknowledge that all athletic activities involving strenuous exertion or potential body contact are hazardous recreational activities and involve substantial risk of injury.

I agree to release, waive and relinquish any and all claims I (or my minor child or ward) may have as a result of participating in these programs against the District, any and all other participating or cooperating governmental units, any and all independent contractors, officers, agents, servants and employees of the governmental bodies and independent contractors, and any and all other persons and entities of whatever nature, that might be directly or indirectly liable for any injuries that I (or my minor child or ward) might sustain as a result of participating in these programs, the District's provision of, or failure to provide, proper instructions or supervision, the use and adjustment of any and all machinery, equipment, and apparatus, and anything related to my use (or the use by my minor child or ward) of the services, facilities, or premises involved in these programs, and transportation to and from any events.

I understand the nature of the programs for which I am registering, either individually or on behalf of my minor child or ward, and have read and fully understand this Waiver and Release of All Claims. I further understand that any advisements or warnings of the particular risks of these programs that I or my minor child or ward subsequently receive will be incorporated by reference into and become a part of this Agreement.

I acknowledge that District staff may photograph participants in District programs, classes or events and that the District may publish any of these photographs in its catalogues, brochures, pamphlets or flyers. I hereby consent to the District taking and publishing photographs of me or my minor child or ward.
