May 10, 2019


1. Call to Order - The Special Board Meeting of the Vernon Hills Board of Park Commissioners was called to order by President Doerhoefer at 8:01 a.m. at the Sullivan Community Center, 635 N. Aspen Drive, Vernon Hills.
2. Roll Call - Present were: Commissioners Doerhoefer, Kessler, Meline and Ballowe. Absent: Commissioner Robbins. Staff: Secretary Jeff Fougrousse, Treasurer Marla DeCicco.
3. Pledge of Allegiance- President Doerhoefer lead the Pledge of Allegiance.
4. Citizens Wishing to Address the Board- There were no comments from the public.
5. New Business

A. Budget & Appropriation Hearing

President Doerhoefer announced that the Budget and Appropriation Ordinance Hearing for fiscal year 2019/2020 was open. President Doerhoefer then stated that in accordance with Illinois State Law, the Budget & Appropriation Ordinance has been made conveniently available for 30 days prior to this Budget Hearing. Notice of this public hearing was published in a newspaper of general circulation, the Chicago Tribune on May 2, 2019. The combined annual Budget and Appropriation Ordinance appropriates the monies that are necessary to cover the projected expenses and liabilities the District may incur in its next budget year, June 1, 2019 through May 31, 2020. The ordinance must be passed and approved within or before the first quarter of the fiscal year. President Doerhoefer then asked if anyone would like to come forward with any comments or questions for the Board concerning the proposed fiscal year 2019/2020 Budget and Appropriation Ordinance. There being no questions from the audience or further Board discussion, the Budget and Appropriation hearing was closed.

6. Adjournment

Commissioner Ballowe motioned for adjournment and Commissioner Meline seconded the motion. A voice vote unanimously adjourned the Special Meeting at 8:03 am.
