**Vernon Hills Park District

**1. Call to Order and Roll Call**

The public hearing of the Vernon Hills Park District was called to order by Vice President Ballowe at 6:30 p.m. at 635 N. Aspen Drive, Vernon Hills, IL 60061.

Vice President Ballowe stated that the Bond Issue Notification Act hearing was open.

Vice President Ballowe stated that the purpose of the Bond Issue Notification Hearing is to hold a public hearing to provide the opportunity for the public to make comments concerning the Board's intent to sell General Obligation Limited Tax Park Bonds before the Board formally votes on the adoption of a Bond Ordinance.

Vice President Ballowe stated that the Board of Park Commissioners intends to sell general obligation limited tax park bonds in 2019, 2020 and 2021 in an aggregate amount not to exceed \$3,300,000 for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District.

Vice President Ballowe stated An Ordinance providing for the issuance of approximately \$1,052,335 General Obligation Limited Tax Park Bonds, Series 2019 will be on the November 21, 2019, Board Agenda.




Vice President Ballowe asked if there were any comments and/or questions from the Park Commissioners with respect to the proposed issuance of bonds? There were none.
