The combined annual Budget and Appropriation Ordinance appropriates the monies that are necessary to cover the projected expenses and liabilities the District may incur in its next budget year, June 1, 2021 through May 31, 2022. The ordinance must be passed and approved within or before the first quarter of the fiscal year.


