- 4. Financial Reports for the Period Ending March 31, 2022 President Pro-tempore Sente asked Finance/HR Superintendent Jessica Mitchell if there were any changes to the reports filed. Jessica confirmed the financial reports stand as filed.
- 5. Welcome to Visitors and Guests Public Comment Period
 - A. State Representative Daniel Didech- Legislative Update- President Pro-tempore Sente invited State Representative Didech to the podium. Rep. Didech commented that Senator Johnson would have liked be present and sends her regards. Rep. Didech reported a very successful year in Springfield for the park district. Funding has been released 200K for Grosse Pointe Tennis Court as well as 250K for the Laschen Park Redevelopment. SB 3467 which voids out the prevision with public utility on indemnification clause has passed both the Senate and House. Thank you to Senator Johnson for her efforts on this bill. Many other park districts will benefit from this bill statewide. A third bill is in the works: the Best Value Bidder bill which creates an alternative to the lowest responsible bidder standard. Senator Johnson is sponsoring this bill in the Senate and Rep. Didech hopes that it will pass both chambers this summer.

Tom Ritter replied that Bobo's provides financial reports to the district via their internal software. Tom confirmed that those reports are reviewed and compared to district interal year end figures. Commissioner Sente verified that those reports are reviewed by Tom and Robert Wood. Commissioner Robbins would like to be able to receive those reports at the end of the season. Commissioner Giraldo clarified that the purpose of the review was to verify that Bobo's records for camp meals and birthday parties matches our internal records.
