Mr. Alexander expressed concern over the current Lakeview hours. He is of the opinion that closing at 3pm on Saturday could prevent new memberships. Mr. Alexander expressed concern that promotional programs offered at other clubs, especially those that are subsidized by insurance carriers are not being offered at Lakeview. Mr. Alexander stated a concern on behalf of his wife that there not enough hooks or benches in the ladies' locker room at Lakeview. Mr. Alexander concluded with a concern that the habitat of wildlife is being disrupted as a result of the work on the Seavey Ditch.

An Ordinance providing for the issuance of not to exceed \$6,000,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2023 will be on the March 23, 2023 Board Agenda.
