Matt reported that the audit would be submitted for the GFOA recognition and that the highest level of opinion by the auditors was once again given to the district for its financial management. F. SRACLC Executive Director John Buckner- John thanked Jeff for his guidance and support of SRACLC over the last 15 years.
