Employee Compensation

In 2011, Public Act 97-0609 became law, effective January 2012. That act amend the Illinois Open Meetings Act and the Illinois Pension Code and establishes new requirements for Illinois public bodies.

Law Requirements

Among the law's requirements are the following:

All IMRF employers must post, within 6 days of the approval of a budget, the total compensation package for each employee having a total compensation package that exceeds \$75,000.

Any IMRF employer that approves an employee's total compensation package equal to or in excess of \$150,000 per year must post on it's website, at least six days before the approval, the total compensation package for that employee
